**TERMS & CONDITIONS**

1. The Delta Community Music School is a not-for-profit organization which undertakes to provide the schedule of instructions set out on the registration form.
2. **REGISTRATION AND MEMBERSHIP FEES** A Membership Fee of \$5.00 per family (as stated in the Society Act) is payable upon registration once per fiscal year (July 1 – June 30<sup>th</sup>) , and a Registration Fee of \$10.00 for each session is payable prior to commencement of each session. These fees are non-refundable.
3. **FEES** are payable in advance for the term. Upon registration, please pay by cash or cheque made payable to "Delta Community Music School or DCMS". **CHEQUES MUST BE DEPOSITED WITH THE SCHOOL BEFORE THE CLASSES COMMENCE. ALL NSF CHEQUES WILL BE CHARGED A \$25.00 HANDLING FEE.**
4. Enrolment is only accepted from those returning students whose fees and accounts are paid up to date and in good standing. Any arrears must be paid in full before subsequent enrolment is accepted.
5. **Members are encouraged to participate in some form of fundraising efforts throughout the year** either individually or at fundraising events.
6. **REFUNDS** will be made **ONLY** if the school cancels the course of study for any reason **OR** in the event of the student's serious illness.
7. **NON-ATTENDANCE AT LESSONS DOES NOT CONSTITUTE WITHDRAWAL**
8. Due to the continuous nature of **GROUP LESSONS** missed classes cannot be made up and if a child is withdrawn from class, fees will remain payable until the end of the session he/she is withdrawn from.
9. The School accepts no responsibility for personal injury occurring at any School activity (including transportation to and from the activity) nor for any damage to instruments or personal property, however caused.
10. **ALL MONIES COLLECTED AS A RESULT OF PERFORMANCES OR PRODUCTION OF A DEMO CD** WILL BE CONSIDERED FUNDRAISING EVENTS FOR DELTA COMMUNITY MUSIC SCHOOL.
